GYMNASTICS EAST ON-LINE WAIVER AND RELEASE INFORMATION

Annual Fee:

There is an annual fee of \$60 per family.

Photo Release:

I hereby give my permission for Gymnastics East to take my photograph or a photograph of my child(ren) and use or publish the likeness for Gymnastics East purposes and I release Gymnastics East any claims for such use.

Attire:

Girls can wear any type of one-piece leotard. No bare midriffs please. Footless tights are optional. Students may go barefoot or wear gymnastics shoes. Please have long hair tied back. No hard balls or barrettes. No jewelry, including knotted strings, beads, nylon bands and similar can be worn during class with the exception of studded earrings.

Boys wear T-shirts and shorts with no buckles, snaps or zippers.

All T-shirts should be tucked into pants.

No gum chewing, eating or drinking (other than water) during class. Water bottles are allowed.

Arrival and Departure:

Children may not be dropped off earlier than ten minutes before their scheduled class nor picked up later than ten minutes after the class has ended. Parents of kindergarten aged children and younger are recommended to wait in the building during class.

Children who are not participating may not be left at the gym without parental supervision.

Gym Rules & Procedures:

I have read the separate Gym Policies sheet (also available <u>online</u>) and will comply with all rules & policies mentioned.

Enrollment:

I understand that my child is <u>enrolled through June 27th, 2020</u> and/or for our summer session (separate registration for summer classes) that runs July & August 2020 unless I withdraw him/her. I need to provide the office a minimum 1 week or greater notice to withdraw at any time. Any credits will be valid for 1 year. A processing fee of \$25 will be charged for any refunds.

Missed Classes:

I understand that there are <u>NO CREDITS OR REFUNDS</u> for missed classes or classes canceled due to weather related issues. Due to space limitations we are unable to provide make ups in our regular classes. Missed classes for Kindergarten thru Middle School can be made up in an Open Gym prior to June 27th, 2020 if your child is currently enrolled and you have paid in full. Sign up

in advance in the office for Open Gym. For Tiny Tot classes, please see the office for class make-up options.

Open Gym Rules & Procedures:

I have read the separate Open Gym Policies sheet (also available <u>online</u>) and will comply with all rules & policies mentioned.

Due to insurance regulations, Adults and unregistered children are NEVER allowed in the gym area or on any equipment.

Children should work only on skills they have already mastered. No one should participate in these sessions and try to perform activities beyond their skill level.

Rules for Open Gym will be explained by the teacher prior to starting as well as posted at the different events. Consequences for breaking the rules: 1st time – Warning; 2nd time – Sit out 10 minutes; 3rd time – Not allowed to attend Open Gym for 2 weeks; 4th time – Restricted from Open Gym thru August 31, 2020.

We do not allow kids Pre-K or younger or High School age children in Open Gym.

Open Gym Cancellation:

School Year Session: Cancellation is required by end of day the Thursday prior to your Open Gym date.

Summer Session: Cancellation is required by end of day the Wednesday prior to your Open Gym

WAIVER

General: In consideration of allowing the below named student to enroll in a gymnastics school program and the use by the students of the premises and the property of said school, the undersigned, being the legal and acting guardians of the student, acting for themselves and on behalf of the student, release and hold harmless Gymnastics East Inc., its owners, officers and employees of and for any and all liability, claims, actions and causes of actions whatsoever, arising out of or relating to any loss, damage or injury that may be sustained by the student while in, on, or upon the premises of Gymnastics East Inc.

Medical Attention: The undersigned, being duly aware of the risks and hazards inherent upon participation in the classes, activities, and events being conducted by Gymnastics East Inc., acting for themselves and the student, hereby elect voluntarily to enter upon said premises under the control of said corporation, knowing their present condition. The undersigned acting for themselves and the student, hereby voluntarily assume all risks of loss, damage, or injury that may be sustained by the student while in said premises described above. In the event of any incident which may require immediate medical / dental or any other emergency attention / care, in which the Legal Guardian cannot be notified in a responsible time through reasonable means, I hereby authorize Gymnastics East to take all necessary actions as it relates to immediate medical training attention, transportation and emergency medical services as warranted in the course of care of the undersigned student. I realize that I will be responsible for all fees and expenses as they may relate to this medical attention paragraph.

Waiver and Release: I am fully aware of and appreciate the risks, including the risk of catastrophic injury, paralysis and even death, as well as other damages and losses associated with participation in a gymnastics event. I further agree that Gymnastics East Inc. along with its employees, agents, officers, and directors shall not be liable for any losses, expenses, or damages occurring as a result of my participation in the class, activities or event except where such loss of damage is the result of the intentional or reckless conduct of one of the groups or individuals identified above.

Acknowledgement: This release shall be binding upon distributes, heirs, next of kin, executors and administrators of the student and undersigned.

By acknowledging below this release the undersigned hereby acknowledges:

- a) that he or she has read this release, understands it and signs it voluntarily.
- b) That the undersigned signing as legal guardian is true legal guardian.

Payments/Tuition:

Tuition will be due: at time of registration, 10/25/19, 01/03/20, 02/28/20 and 04/24/20/.

Tuition will be the same each time regardless of holidays and/or closures.

Tuition paid more than 7 days after the due date will be charged a \$20 late fee. If tuition is not paid 14 days after the due date your child will be un-enrolled and will lose their spot in the class.

If you are on autopay and your credit card is rejected, there is a \$10 fee. We accept VISA or MasterCard. NSF checks receive a \$25 fee.

Additional registrations will be given 10% off the least expensive class.

Our school year session runs consecutively from September 5th, 2019 to June 27th, 2020. <u>You are automatically enrolled and responsible for payment through June 27th, 2020 unless a minimum of one week's notice is given to an office staff member. You must register separately for summer classes that run July & August with a one-time payment due upon registration.</u>

A \$60 annual registration fee per family.

If I accept enrollment in Gymnastics East Autopay, I understand that my credit card will be billed for tuition: at time of registration and on the due dates of 10/25/19, 01/03/20, 02/28/20 and 04/24/20/. Other outstanding charges will be billed the first of each month. If I prefer not to enroll in autopay, I understand that my payment must be made prior to each tuition payment date. Payments may be made online or by contacting our office. We accept cash, checks made payable to Gymnastics East, and credit card (Visa or Mastercard).

Should I dispute a charge through my financial institution this will constitute a breach of contract possibly resulting in, but not limited to, penalties, additional fees, collection, legal action, and/or termination of any and/or all current and future services.
